Mr. William Stoermer, Mr. Brian Mays and Mr. Adam Slahor of Exelon Nuclear presented information on the subject of spent fuel storage. Mr. Stoermer explained that used or "spent" nuclear fuel is a by-product of nuclear power plant operations. The Exelon LaSalle Station will accommodate spent fuel storage on-site by using a dry cask storage system. The storage units are being built now and Exelon hopes to start loading the dry casks by next year.

Old Business:

Public Property Victor:

Comm. Victor spoke about the recent flooding caused by the past weekend's rainfall. Comm. Victor, along with Mayor Spicer, Comm. Lamb, Scott Holman, Paul Rivett worked Saturday and Sunday to help alleviate flood concerns. Comm. Victor also announced that FEMA possibly would be contacting Village Hall at a later date.

Public Health & Safety Hamilton:

Comm. Hamilton stated that the ambulance contract is currently under Council review and that it will be brought up at a later date.

Comm. Hamilton announced that the EMA Coordinator pending vacancy is still currently open, he would like to touch base with each applicant prior to the appointment.

**Public Affairs Mayor Spicer:**

Mayor Spicer addressed the Council with information on the candidate he has selected to fill the Plan Commission vacancy, Mr. Frank Hall.

**Public Affairs Mayor Spicer:**

Mayor Spicer addressed the Council regarding a request from the Seneca Ministerial Association to use the Village Hall parking lot on October 5, 2008. The Council unanimously approved the church use of the parking lot for a CROP walk starting point.

Mayor Spicer announced a save "Illinois State Park Rally" on Sunday, September 21<sup>st</sup> at the Illini State Park in Marseilles, Illinois. Along with the rally announcement, Mayor also recommended to Council a resolution of support in removing the surrounding area parks from the list of State park closings as well as a petition available at the Seneca Village Hall for resident signatures.
