Public Property Victor:

Comm. Victor gave an overview of the Seneca clean up days held in June, 2009. Eighteen dumpsters were filled and approximately \$8000.00 was spent for salaries, food and garbage company fees. Comm. Victor asked the Council if they would approve a donation to the Seneca FFA as that organization was responsible for hauling the garbage off the senior & disabled properties.

Public Health & Safety Sears:

Comm. Sears stated the bidding on the 2004 Crown Victoria squad car was completed on 7-20-09 with highest bid going to Bay Ridge motors for \$1711.00.

A property sale ordinance was placed on file with the Clerk and will be voted on at the next Council meeting.

Comm. Sears announced Seneca's participation in the National Night Out Campaign which will take place on August 4, 2009. This event is to raise awareness for community policing, crime prevention and the neighborhood watch program. It was mentioned that due to a small community parade taking place at 7pm on 8-4-09, same date of next Council meeting that the Council meeting will be moved to start at 7:15pm.

Streets Lamb:

Comm. Lamb gave a bridge update regarding the extension of the completion date to late 2010. This is due in part to the river bed drilling delays which was no fault to the contract engineers.

A street report was also given by Comm. Lamb regarding the process of strip patching which has started on Walnut & Oak Streets and will follow with Scott Street.

A high pressure pump will be used to clean the swale discharge pipe at Crotty Creek and the cleaning of the canal will follow.

Public Health & Safety Sears:

Commissioner Sears announced a new part-time employee at the police department.

Mayor Spicer thanked all volunteers involved with the Seneca Shipyard Festival as well as the Cruise Night committee. The events were well received by the public and the Village Council appreciates their efforts.
