Public Health & Safety Sears:

Public Affairs Mayor Spicer

Mayor Spicer announced that North Central Illinois Council of Governments has asked Seneca for \$1000.00 toward the local share needed to match the 50/50 Annual Planning Grant of \$63,628.00; he stated this expense was in his budget, therefore he asked Council for their consensus on whether to make this donation.

A motion was made by Comm. Sears and seconded by Comm. Lamb that the Council approves an expenditure of \$1000.00 to North Central IL Council of Governments.

Mayor Spicer announced that the Seneca I-80 Railport project is not developing as expected due to economy and lack of interest, the investors have decided to sell the land and therefore asked Village for an amendment to the existing annexation agreement. An outstanding bill is owed to the Seneca Port Authority for their expense of the creation of the TIF District, the Village is asking for full payment of this expenditure as well as a 20 acre parcel donation to the Village of Seneca. Commissioner Timmons added he would like to make certain that the Village is in receipt of all records pertaining to the land surveys performed by various contractors during the process. Two parcels were reviewed by the Council, and it was determined that by consensus of Council area one would be the choice of Council for the land donation. An additional announcement was made by Mayor Spicer that a public hearing will be held at 7:00pm on September 3, 2013 for the annexation agreement amendments.

Commissioner Sears gave his congratulations to Village Clerk Therese Russell for her 2013 Municipal Clerk's Academy scholarship.

A motion was made by Comm. Lamb and seconded by Comm. Sears that the Council enters into executive session to discuss Purchase or Lease of Real Estate.
