Commissioner Lamb said he would like to congratulate Michael Ellis on the fine job that the Seneca Summer Festival Committee did with the 2011 festival.

New Business:

Public Property Hamilton:

Comm. Hamilton stated the Village will be starting to replace fire hydrants on Thursday, July 7<sup>th</sup> at 9:00am in the Englewood Drive area. It was announced that anyone living in that area will be without water during that time and that after water has been turned back on then a boil water order will be in effect until further notice. In addition, Commissioner Hamilton stated that previously the Park Board presented the Council with a motion allowing Margaret Grober to hire a summer part-time temporary employee to work at the various park areas throughout the Village at \$10.00 per hour. It was discussed by the Village to allow Margaret to interview candidates and hire such employee.

A motion was made by Comm. Hamilton and seconded by Comm. Lamb that the Village Council authorizes the Seneca Park Board to hire up to two part-time temporary employees utilizing Park Board funds.

Accounts & Finance Timmons:

Commissioner Timmons stated the Sea Cadets have started working in the Village of Seneca at the Crotty Park to build a basketball court and at the Seneca Boat Launch to install BBQ grills/concrete pads as well as other community projects. Commissioner Timmons publically thanked the Sea Cadet program for their time and efforts within our community. Comm. Timmons announced that the Village will hold a Budget Meeting on July 12, 2011 at 6:30pm.

Streets Lamb:

Comm. Lamb referred to Village Engineer, Guy Christensen for explanation of the Village Motor Fuel Tax program. As explained, The Motor Fuel Tax Funds that the

Village of Seneca receives are distributed by the State of Illinois from taxes on gasoline and diesel fuel. After the State funds various administrative, regulatory, railroad, and boating requirements, the balance of the funds are allotted monthly to Counties, Townships, and Municipalities, with municipalities receiving about 27% of those available funds. A municipality's share of the total MFT municipal allocation is based on the ratio of that municipality's population to the total population of all incorporated areas in the State. The allotment of each municipality is not based on the total fuel tax collected within that municipality's boundary. It is based on State wide sales.

A motion was made by Comm. Lamb and seconded by Comm. Timmons that the Council appropriate Motor Fuel Tax funds for the 2011 street maintenance program.

Under intersection lighting announcement, Comm. Lamb stated that the Village is working with Commonwealth Edison to provide lighting to the intersection of River Road and Dupont Road as well as River Road and 29<sup>th</sup> Road. For the storm sewer announcement he stated if all materials are received that the project will begin approximately July 11, 2011. It has been determined that the culvert on Commerce Street has become filled with gravel and sand and Village will need to hire A & E Septic to utilize a special Vactor machine for the removal job.

A motion was made by Comm. Lamb and seconded by Comm. Hamilton that the Council approves A & E Septic to be hired to clean culvert on Commerce Street.

Public Affairs Spicer:

Mayor Spicer stated that he received a request from Michael Ellis to change the name from the Seneca Summer Festival Committee to the Seneca Festival Commission. Michael explained that the Seneca Park Board has given him the authority to begin preparations for the Fall Festival and Golf Cart Cruise and by changing the name it will allow the committee to plan for other events and festivals that are other than just summer months. It was determined by the Village to appoint the Seneca Festival Commission board members as well.

A motion was made by Comm. Hamilton and seconded by Comm. Timmons that the Council approves a name change from Seneca Summer Festival Committee to the Seneca Festival Commission.
