**Public Property Timmons:** 

Commissioner Timmons announced that the Park Board will be sponsoring a "Seneca Night" at the Silver Cross Stadium for a Slammers game on July 11, 2015; he presented ticket information. In addition, he stated that Village employees will be making a water meter replacement at Mariner's Village in the near future and that residents should not be affected. Also, the standpipe will be undergoing an inspection due to a leak; this will involve draining and examining the tank and sealing leak; in addition, a valve installation will need to take place prior at a cost of approximately \$5,174.00 total. The valve installation will provide a live tap capability, thus no boil order to residents or businesses should occur. The Village maintenance staff will work with the contractor to provide the labor, creating a savings to the Village. Consensus of council to allow \$500.00 expense to Midwest Chlorinating and a motion was presented for the main expenditure to Underground Pipe & Valve.

A motion was made by Comm. Timmons and seconded by Comm. Barla that the Council approves an expenditure of \$4,674.00 to Underground Pipe & Valve out of the Water Department Fund.

Commissioner Timmons stated in addition that a replacement is set for June 17, 2015 on well #3; it is believed that the pump has malfunctioned and it has been researched that pump is still under warranty. Commissioner Timmons stated it should take approximately 1-2 days to complete and update. The question was posed as to whether the new installation of pump will extend the current warranty starting on the new installation date, Commissioner Timmons was unaware of the answer and indicated he would check on it.

## Streets Olson:

Commissioner Olson commended entire maintenance staff including the summer help for their efforts during the recent flooding situation; he announced there were nine truckloads of debris removed from the creek areas and that residents should be patient during the cleanup process.

## Public Health and Safety Applebee:

Commissioner Applebee announced that the Seneca Police staff conducted their 21<sup>st</sup> Tobacco Compliance Check of the Seneca tobacco retailers; there were no sales of tobacco products to minors and the program is fully funded by a yearly grant. Comm. Applebee referred to Kathy Haralson, EMA Director for an update on the recent flooding. Ms. Haralson stated that on today's date, LaSalle County had declared an emergency at 1:30pm due to the current flooding that was experienced and in preparation for the potential precipitation expected next weekend. Also, the Seneca Boat Launch has been closed until further notice and she indicated the last flooding was severe by the Seneca Waste water treatment plant, and a plan for sandbags should be devised; Comm. Applebee thanked Ms. Haralson for her efforts. An announcement was made regarding the many efforts of the 2015 Sesquicentennial Committee, the celebration is set for June 24, 2015 to June 28<sup>th</sup> and includes a carnival midway on Williams Street, live bands, beer garden, beard contest, historical displays and tours, kid's activities, shipyard shuffle 5K run/walk event, shipyard workers day, founders day and fireworks.

## Public Affairs Mayor Spicer:

Mayor Spicer stated the Village is hosting a cleanup event on Friday, June 19<sup>th</sup> and Saturday June 20<sup>th</sup>; he announced all details. In addition, the Village has given approval for the IL Valley Building Trades Council to hold its annual fundraiser for Dollars Against Diabetes, Dad's Day scheduled for Saturday, June 20, 2015. Mayor Spicer stated the previous Village council declined to pay for the 2015 Illinois River Area Chamber of Commerce membership dues; he asked the current council to review again and after discussion it was agreed that the consensus of council was to allow the expenditure of \$480.00. Mayor Spicer also indicated he had reached out to Marseilles Mayor James Trager on behalf of the Seneca Village Council to provide flood relief if needed; Mayor Spicer thanked Commissioner Barla for providing the call idea.
