

The Seneca Village Council held a regularly scheduled Council meeting at Seneca Village Hall on May 19, 2015.

Village council meeting called to order at 7:00pm

Mayor Spicer stated an error was made to May 5, 2015 minutes that included the term date for Village officers, Frank Hall, Kathleen Haralson, Evie Helm motions be corrected to 2019 instead of 2020.

In Commissioner Timmons' absence, Mayor Spicer announced the agenda item of hiring Zach Russell for temporary help in the sewer department.

Public Affairs Spicer:

Mayor Spicer stated the Prevailing Wage Ordinance is up for passage and a requirement by State statute to adopt yearly.

An announcement was made regarding the Seneca Historical Guild book release which will take place Saturday, June 6, 2015 at the Seneca High School. Mayor Spicer stated that the Park Board wished to announce with the help of Jim Olson; removal has occurred of the railroad spur tracks and ties from Williams Street to Douglas, landscaping and seeding will take place when weather permits.

New Business:

Streets Olson:

Commissioner Olson announced that he had researched many vendors for the rental of a boom mower; lowest quote was Burris Rental and with delivery and pickup the final cost for a weekly rental is \$2300.00.

A motion was made by Comm. Olson and seconded by Comm. Barla that the Council approves an expenditure of \$2300 to Burris Equipment for mower use out of Public Benefit Fund.

Public Health and Safety Applebee:

Comm. Applebee gave an announcement regarding ordinance 92-14; he stated it is a violation to allow grass or weeds to grow more than 8" high and if allowed, may result in a ticket and/or fines being issued. Also, Comm. Applebee stated it is against the law to intentionally throw grass clippings into the public roadways.

Public Affairs Mayor Spicer:

Mayor Spicer stated an investor billing was received from Grundy County Economic Development for \$500.00; consensus of Council was to proceed with paying this billing. Mayor also announced that the appointment for Gary Hamilton to be the public member on the 911 Board was up for passage.

A motion was made by Comm. Applebee and seconded by Comm. Olson that the Council approves Gary Hamilton appointment to the 911 Board with term ending May, 2018.
